

EFFECTIVE DATE: This resolution shall take effect immediately upon passage.

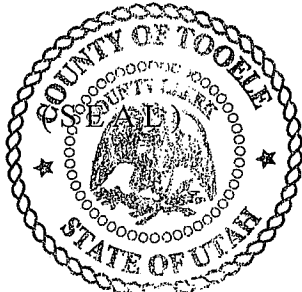

SECTION 22
PARKING

- A. **PURPOSE**: The purpose of this policy is to ensure adequate parking for employees and to better serve the patrons during normal working hours.
- B. **FRONT SOUTH LOT**: Employees will be permitted to park in the front south lot in designated areas only or in the East lot behind the county building.
- C. **LOADING ZONES**: Thirty minute loading/unloading zones will be provided in designated areas which may be used by employees for that stated purpose.
- D. **FRONT NORTH LOT**: Parking by permit only will be allowed in the front north lot.

**SECTION 22
COURTHOUSE PARKING**

- A. **PURPOSE:** The purpose of this policy is to ensure adequate parking for courthouse employees and to better serve the patrons of the courthouse during normal working hours ~~8:00 a.m. to 5:00 p.m.~~
- B. **EAST LOT:** ~~All courthouse employees are required to park in the east parking lot at the rear of the courthouse. Parking will be on a first come, first served basis.~~
- C. **FRONT SOUTH LOT:** ~~Parking in the front south lot is limited to two hours and shall be for patrons only. No employees of the courthouse will be permitted to park in the front south lot in designated areas only or in the East lot behind the county building.~~
- DC. **LOADING ZONES:** Thirty minute loading/unloading zones will be provided in designated areas which may be used by courthouse employees for that stated purpose.
- ED. **FRONT NORTH LOT:** ~~Parking by permit only will be allowed in the front north lot. Each county elected office will be assigned one parking space.~~
