WHEREAS, pursuant to Utah Code Annotated, Sections 17-36-12 and 17-36-13, a public hearing on the adoption of the budget was regularly noticed up and conducted by the Tooele County Commission on December 11, 2001; and

WHEREAS, Utah Code Annotated, Section 17-16-14, requires the Tooele County Commission to fix the salaries of the Tooele County officers for the 2002 fiscal year;

NOW, THEREFORE, BE IT RESOLVED that the 2002 fiscal year budget for Tooele? County, attached hereto as Exhibit A and by this reference made a part hereof, and the annual salaries for the fiscal year 2002 for Tooele County officers, presented on the attached Exhibit B, and by this reference made a part hereof, are hereby adopted and fixed as so stated.

^{*}Any chief deputy hired within the 2002 fiscal year shall be paid \$4,000 less than the stated annual base salary which shall be prorated from their hire date.

Except as provided below, the above-referenced Tooele County officer shall receive, in addition to the above-mentioned salaries, the same retirement and other fringe benefits afforded all other Tooele County employees. The above-referenced <u>elected</u> officers shall receive the insurance benefits provided other county employees, including family health/dental coverage at a total annual cost of \$1,870.44 to each of the officers that elects to obtain family coverage. Chief deputies shall receive the same insurance benefits provided other non-elected county employees at the same cost as regular county employees.

The surveyor and Justice Court judges shall receive, in addition to the above-mentioned salaried, all insurance, retirement, and other employee benefits afforded other non-elected Tooele County employees.

The Tooele County constable shall not receive any compensation, salary, insurance or other employee fringe benefits afforded other county employees. The constable's reimbursement shall be derived exclusively from statutory fees charged for services provided.
