#### RESOLUTION NO. 2009-16

DECLARATION OF OFFICIAL INTENT OF THE BOARD OF COUNTY COMMISSIONERS (THE "COMMISSION") OF TOOELE COUNTY, UTAH (THE "COUNTY"), TO REIMBURSE THE COUNTY FROM THE PROCEEDS OF TAX-EXEMPT BONDS FOR CERTAIN CAPITAL EXPENDITURES ADVANCED BY THE COUNTY TO FINANCE THE CONSTRUCTION OF ROAD IMPROVEMENTS AND EXPENSES; ESTABLISHING THE MAXIMUM PRINCIPAL AMOUNT OF SUCH EXPENDITURES; AND RELATED MATTERS.

WHEREAS, Tooele County (the "County"), expects to incur significant costs in connection with constructing road improvements and other related improvements (collectively, the "Project") and intends to issue tax-exempt bonds to finance said Project; and

WHEREAS, no costs of the Project to be reimbursed will have been paid more than sixty (60) days prior to the date of this Resolution, other than preliminary expenditures (not exceeding twenty percent (20%) of the aggregate issue price of the Tax-Exempt Bonds issued to finance the Project), provided that such preliminary expenditures shall not include costs of land acquisition or site preparation or other costs of construction or acquisition of the Project;

#### NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- Section 1. <u>Declaration of Official Intent to Finance Capital Expenditures:</u> <u>Maximum Authorized Debt</u>. The County hereby declares its intention and reasonable expectation to use proceeds of Tax-Exempt Bonds to reimburse itself for expenditures for a portion of the costs of the Project including preliminary expenses. The Tax-Exempt Bonds are to be issued, and the reimbursements made, by the later of eighteen (18) months after (a) the payment of the costs or (b) the date the Project is placed in service, but in any event, no later than three years after the date the original expenditure was paid. The maximum principal amount of the Tax-Exempt Bonds which are expected to be issued to finance the Project is not expected to exceed \$4,466,507.
- Section 2. <u>Nature of Project Costs</u>. The costs of the Project consist entirely of capital expenditures or costs of issuance of the Tax-Exempt Bonds, and no cost of the Project to be reimbursed with the proceeds of the Tax-Exempt Bonds is a cost of working capital.
- Section 3. <u>Incidental Action</u>. The Chair and County Clerk are hereby authorized and directed to take or approve the taking of such actions as may be necessary or appropriate in order to preserve the ability of the County to facilitate the financing of the Project in accordance with the federal tax regulations and this Resolution.
- Section 4. <u>No Replacement Proceeds</u>. The County will not, at any time within one year after any allocation of proceeds of the Tax-Exempt Bonds to reimburse any expenditure, use the reimbursed funds to create a sinking fund for any issue of Tax-Exempt Bonds, or to otherwise replace the proceeds of any issue of Tax-Exempt Bonds.

Section 5. Effective Date: Repeal. This Resolution shall take effect immediately. All prior resolutions or portions thereof inconsistent herewith are hereby repealed.
