A RESOLUTION RE-ESTABLISHING THE SALARIES OF THE TOOELE COUNTY OFFICERS FOR THE 2015 FISCAL YEAR AS A RESULT OF THE 2015 MID-YEAR COLA AND AN ADJUSTMENT TO THE SALARIES FOR COUNTY COMMISSIONERS

WHEREAS, pursuant to Utah Code Annotated, Section 17-16-14, on July 2, 2015 notice of a public hearing on the 2015 salaries of County officers was published; and

WHEREAS, pursuant to Utah Code Annotated, Section 17-16-14, the public hearing was conducted by the Tooele County Commission on July 7, 2015 and all interested persons were given an opportunity to be heard; and

WHEREAS, Utah Code Annotated, Section 17-16-14, requires the Tooele County Commission to fix the salaries of the Tooele County officers by resolution.

NOW, THEREFORE, BE IT RESOLVED that the annual salaries for Tooele County officers for the 2015 fiscal year are amended to include the 2015 mid-year COLA as well as an adjustment to the salaries for County Commissioners, as presented on the attached Exhibit A, and are hereby adopted.

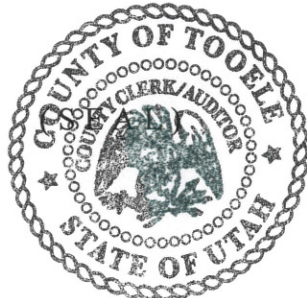

All County officers listed above shall receive, in addition to the above-mentioned salaries, the same retirement and other fringe benefits afforded all other Tooele County employees, including family health/dental coverage at the same cost as regular county employees.

Tooele County constables shall not receive any compensation, salary, insurance, or other employee fringe benefits afforded other county employees. The constables' reimbursement shall be derived exclusively from statutory fees charged for services provided.
