

## RESOLUTION 2018-11

**A RESOLUTION PROVIDING NOTICE OF TOOELE COUNTY'S INTENT TO RAISE TAXES; THE COUNTY GENERAL OPERATIONS LEVY WOULD BE INCREASED BY 5%, GENERATING \$288,494 IN ADDITIONAL REVENUE, AND THE COUNTY HEALTH DEPARTMENT LEVY WOULD BE INCREASED BY 5%, GENERATING \$37,466 IN ADDITIONAL REVENUE, WHICH WILL BE USED TO PAY FOR INCREASED ASSESSING AND COLLECTING COSTS, INFLATION, AND EMPLOYEE HEALTH COSTS**

**NOW, THEREFORE, BE IT RESOLVED** that the Board of County Commissioners of Tooele County, Utah, pursuant to UCA 59-2-919, hereby provides public notice of its intent to increase the County General Operations levy by 5% and the County Health Department levy by 5%. The increased County General Operations levy would generate an additional \$288,494 in property tax revenue and the increased County Health Department levy would generate an additional \$37,466 in property tax revenue. The increased revenue will be used to pay for increased assessing and collecting costs, inflation, and employee health costs.

If the proposed tax increase is approved, the County General Operations levy on a \$240,000 residence will increase from \$192.06 to \$201.66, which is \$9.60 per year, and the County General Operations levy on a \$240,000 business will increase from \$349.20 to \$366.66, which is \$17.46 per year. The County Health Department levy on a \$240,000 residence will increase from \$24.95 to \$26.20, which is \$1.25 per year, and the County Health Department levy on a \$240,000 business will increase from \$45.36 to \$47.63, which is \$2.27 per year.

All concerned citizens are invited to a public hearing on the tax increase at the County Commission Meeting held on November 20, 2018 at 7:00 p.m. in Room 321 of the Tooele County Building at 47 S. Main Street in Tooele, Utah.
