ORDINANCE 2001-15

AN ORDINANCE AMENDING THE ADDRESSES OF CERTAIN LOTS IN BRYAN SUBDIVISION

THE COUNTY LEGISLATIVE BODY OF THE COUNTY OF TOOELE ORDAINS

AS FOLLOWS:

SECTION I - PURPOSE: The purpose of this ordinance is to correct addressing errors regarding certain lots in the Bryan Subdivision in Tooele County. SECTION III - REPEALER. Ordinances in conflict herewith are hereby repealed to the extent of such conflict.





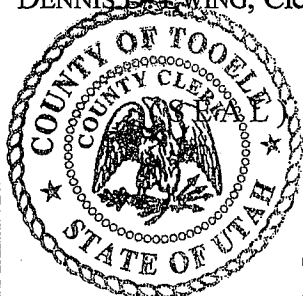
