ORDINANCE 2007-15

AN ORDINANCE REDISTRICTING TOOELE COUNTY VOTING PRECINCTS

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOELE COUNTY, UTAH AS FOLLOWS:

SECTION I - PURPOSE. This ordinance is for the purpose of establishing, dividing, and amending Tooele County election precincts, pursuant to Utah Code Annotated 20A-5-303.

SECTION II - REPEAL OF CONFLICTING ORDINANCES. All Tooele County ordinances or parts of ordinances in conflict with any provision of this ordinance are hereby repealed.

SECTION III - REDISTRICTING OF TOOELE COUNTY ELECTION PRECINCTS.

There are hereby established forty (40) election precincts within Tooele County as described by the maps attached hereto, which are by this reference, made a part hereof. The abbreviated designations for each precinct on the attached maps shall be interpreted according to the following legend: T1 through T19 refers to Tooele precincts #1 through #19; G1 through G5 refers to Grantsville precincts #1 through #5; LP refers to Lake Point; SP1 through SP5 refers to Stansbury Park precincts #1 through #5; ER1 and ER2 refer to Erda precincts #1 and #2; LI refers to Lincoln; ST refers to Stockton; OP refers to Ophir; RV refers to Rush Valley; VE refers to Vernon; TE refers to Terra; DU1 and DU2 refer to Dugway precincts #1 and #2; IB refers to Ibapah; and WE refers to Wendover. The election precincts affected by this redistricting are T13.1, T13.2, T15, T16, T18, T19, G3, G5, SP1.1, SP1.2, SP2.1, SP3.1, SP3.2, SP3.3, SP4.1, SP5.1, ER1, ER2, DU1, and DU2.

SECTION IV - MAP INTERPRETATIONS. It is intended that election districts be divided by roadways, where possible. If a map shows a boundary close to but not exactly on a road, the road shall nevertheless be considered the dividing line.


