ORDINANCE 2015-11

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF TOOELE COUNTY; REZONING APPROXIMATELY 14.83 ACRES OF LAND IN ERDA, EAST OF SR-36, FROM RR-5 TO RR-1

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOELE COUNTY, UTAH AS FOLLOWS:

SECTION I – AMENDMENT. An application for rezone was submitted by Roselane Wrathall and Georgia Warr. The County Planner noticed four adjacent properties which are below the required lot size and determined they should also be included in the rezone. The properties belong to Gary Dekorver, Monte Warr, and Curtis Warr. Pursuant to Utah Code Annotated Sections 17-27a-502 and 17-27a-503, the Tooele County Planning Commission conducted a public hearing on the proposed rezone and recommended the amendment to the official zoning map.

Notice having been provided as required by UCA Subsection 17-27a-205(1)(b) and having held a public meeting, the official zoning map of Tooele County is hereby amended by changing the zoning designation of approximately 14.83 acres which includes Parcel # 05-043-0-0022, Parcel # 05-043-0-0043, Parcel # 05-043-0-0046, Parcel # 05-043-0-0047, Parcel # 05-043-0-0048, Parcel # 05-043-0-0049, Parcel # 04-043-0-0050, Parcel # 05-043-0-0051, and Parcel # 05-043-0-0052, located in Section 27, Township 2 South, Range 4 West in Erda, east of SR-36, at approximately 4800 to 5000 North, in Tooele County, Utah from RR-5 (Rural Residential, Five Acre Minimum Lot Size) to RR-1 (Rural Residential, One Acre Minimum Lot Size).
