the Redevelopment Agency of Tooele County on July 7, 2020;

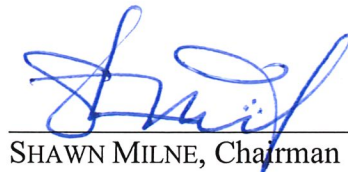
NOW, THEREFORE, BE IT RESOLVED BY THE REDEVELOPMENT
