## TOOELE COUNTY ORDINANCE 2020-24

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF TOOELE COUNTY; REZONING APPROXIMATELY 926.16 ACRES OF LAND ALONG SR-73, SOUTH OF OPHIR CANYON AND FIVE MILE PASS, FROM MU-40 TO M-G

NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOELE COUNTY, UTAH AS FOLLOWS:

**SECTION I – AMENDMENT.** Pursuant to Utah Code Annotated Sections 17-27a-502 and 17-27a-503, the Tooele County Planning Commission conducted a public hearing on the application for rezone submitted by Scott Sanderude on behalf of Dyno Nobel and made a favorable recommendation to amend the official zoning map.

Notice having been provided as required by UCA Subsection 17-27a-205(1)(b) and having held a public meeting, the official zoning map of Tooele County is hereby amended by changing the zoning designation of approximately 926.16 acres, known as Parcels 06-080-0-0004, 06-080-0-0009, and 06-080-0-0010, located along SR-73, south of Ophir Canyon and Five Mile Pass in Tooele County, Utah from MU-40 (Multiple-Use, 40-Acre Minimum Lot Size) to M-G (Manufacturing General).

The legal description and a map showing the area of the rezone are attached hereto and by this reference made a part hereof.

**SECTION II – REPEALER.** Ordinances and resolutions in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION III – EFFECTIVE DATE.** This ordinance shall become effective fifteen (15) days after its passage, provided it has been published, or at such publication date if more than fifteen (15) days after passage.

## **Legal Description of Rezone**

Thence along the south line of said Section 31 South 89°34'08" West 507.80 feet to a point on the northeasterly right-of-way line of State Road 73; thence departing said south line and along said State Road right-of-way line North 44°47'07" West 6786.84 feet to a point on the west line of said Section 31; thence departing said State Road right-of-way line and along said west line North 00°34'57" East 464.44 feet to a found 1943 3" brass cap General Land Office (G.L.O.) monument at the northwest corner of said Section 31; thence departing said west line of Section 31 and along the west line of Section 30, Township 6 South, Range 3 West, Salt Lake Base and Meridian North 00°39'51" East 2660.13 feet to a found 1943 3" brass cap G.L.O. monument at the west guarter of said Section 30; thence along said west line North 00°32'56" East 2660.33 feet to a found 1926 brass cap G.L.O. monument at the northwest corner of said Section 30; thence departing said west line and along the north line of said Section 30 North 89°22'23" East 308.35 feet; thence departing said north line and along the southwesterly line of the Buffalo Lode mining claim South 38°30'37" East 1118.04 feet to corner number 4 of said mining claim, said corner also being known as corner number 2 of the Frances Lode mining claim; thence departing said southwesterly line and along the northwesterly line of the Frances Lode mining claim South 45°28'23" West 600.00 feet to corner number 1 of said mining claim; thence departing said northwesterly line and along the southwesterly line of said Frances Lode mining claim South 61°27'37" East 1500.00 feet to corner number 4 of said mining claim, said corner also being known as corner number 1 of the Cedar Grove Lode mining claim; thence departing said southwesterly line and along the southwesterly line of the Cedar Grove Lode mining claim South 44°01'37" East 1500.00 feet to corner number 4 of said mining claim, said corner also being known as corner number 2 of the Cedric No. 3 Lode mining claim; thence departing said southwesterly line and along the northwesterly line of the Cedric No. 3 Lode mining claim South 45°06'23" West 604.00 feet to corner number 1 of said mining claim; thence departing said northwesterly line and along the southwesterly line of said mining claim South 25°23'37" East 1333.20 feet to corner number 4 of said mining claim; thence departing said southwesterly line and along the southeasterly line of said mining claim North 45°06'23" East 608.93 feet to a point on the southwesterly line of the Cedric No. 2 Lode mining claim, said point also being corner number 3 of the Cedric No. 3 lode mining claim; thence departing said Cedric No. 3 Lode southeasterly line and along the southwesterly line of said Cedric No. 2 Lode South 25°35'37" East 21.54 feet to corner number 4 of said mining claim; thence departing said southwesterly line and along the southeasterly line of said mining claim North 45°28'23" East 608.00 feet to corner number 3 of said mining claim, said corner also being known as corner number 1 of the Molly Bawn Lode mining claim; thence departing said southeasterly line and along the southwesterly line of the Molly Bawn lode mining claim South 29°40'37" East 1435.80 feet to corner number 4 of said mining claim; thence departing said southwesterly line

and along the southeasterly line of said claim North 53°39'23" East 600.00 feet to corner number 3 of said mining claim; thence departing said southeasterly line and along the northeasterly line of said claim North 29°40'37" West 955.98 feet to a point on the north line of the south half of the southeast quarter of said Section 30; thence departing said northeasterly line and along said north line North 89°25'23" East 653.14 feet to a found 1974 3.5" brass cap B.L.M. monument at the east sixteenth of the southeast quarter of said Section 30; thence departing said north line and along the east line of said Section 30 South 00°48'50" West 1329.50 feet to a found 1974 3.5" brass cap B.L.M. monument at the northeast corner of said Section 31; thence departing said east line and along the east line of said Section 31 South 00°53'34" West 2668.76 feet to a found 1974 3.5" brass cap B.L.M. monument at the East Quarter of said Section 31; thence along said east line South 00°52'29" West 2664.13 feet to the **Point of Beginning.** 

The above-described contains 29,634,376 square feet or 680.31 acres.

## **BASIS OF BEARING**

South 89°34'08" West, being the bearing between found Bureau of Land Management (B.L.M.) monuments at the Southeast corner and the South Quarter of Section 31, Township 6 South, Range 3 West, Salt Lake Base and Meridian.
