Additional Funding Approved:

Item 1:

The county is awarded an additional \$5,869 for the existing grant funded attorney contracts as requested below, in order to restore the grant to FY20 funding levels for the months of January through June 2021. Reimbursement will be according to the attached Amended Quarterly Payment Structure.

Item 2:

The county is awarded \$15,600 to hire administrative staff as described below. Reimbursement will be available for costs incurred during the months of January through June 2021, at a rate of \$15 per hour, on an as-billed basis.

Item 3:

The county is awarded \$1,800 for the use of a paid law clerk/intern at the rate of \$15 per hour as-billed. Reimbursement is for expenses incurred during the period of January through June 2021. The position must be filled as soon as possible.

Request Received:

Item 1:

Tooele County is requesting an additional \$5,869 for contracted public defense attorneys. This amount will restore funding to the FY20 amounts for these positions for the period of January 2021 to June 2021.

Item 2:

Tooele County is requesting \$15,600 for administrative staff for public defense attorneys. This funding would be disbursed at the rate of \$15 per hour for an estimated 40 hours per week, which may be distributed between two part-time positions. We understand this funding creates a new position that would potentially only be funded for a six-month period if the funding cannot be renewed. If awarded this funding, we would be mindful of this potential issue during the hiring process, including exploring alternate funding options if that becomes necessary. If this request can be partially funded, we anticipate hiring someone for this position for as many hours per week as the position can be funded. Even if this position can be funded for only ten hours per week, it would allow all attorneys to receive support for tasks such as data entry, sending discovery to clients, and assisting clients with court log-in information.

Item3:

Tooele County is requesting \$1,800 for a law clerk to assist with researching and drafting. This funding would be disbursed at a rate of \$15 per hour for an estimated 20 hours per month.
