**A RESOLUTION ADOPTING THE FINAL 2021 TAX RATES AND
BUDGETED PROPERTY TAX REVENUE AMOUNTS FOR THE
GENERAL COUNTY OPERATIONS LEVY AND THE COUNTY
HEALTH LEVY**

WHEREAS, the Tooele County Council is required by law to adopt final tax rates sufficient to fund its 2021 budget;

NOW, THEREFORE, BE IT RESOLVED by the County Council of Tooele County, Utah, that the 2021 fiscal year final tax rates and budgeted property tax revenues, to be collected county-wide, for the General County Operations Levy and the County Health Levy are hereby established as follows:



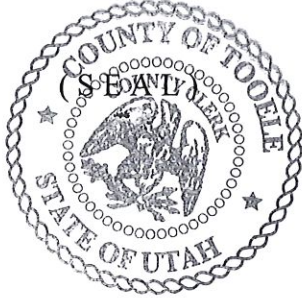


