Summary:

Grant from (VOCA) Victims of Crime Act awarded \$61, 594.44 for year 1 and \$54,8869.44 for year two with a total of \$116,463.88.

VOCA victim assistance funds support states and communities, including American Indian tribes and Alaska Native villages, with direct services which respond to the immediate needs of crime victims, so that the severity of the psychological trauma is reduced; assist the victim in participating in the criminal justice process; and help restore the victim's sense of dignity, self-esteem, and coping mechanisms.
