

**TOOELE COUNTY
ORDINANCE 2021-28**

**AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP OF
TOOELE COUNTY; REZONING APPROXIMATELY 47.41 ACRES OF
LAND, LOCATED AT 5047 N. DROUBAY ROAD IN ERDA, FROM RR-5
TO RR-1**

WHEREAS, Tom Parker requested a rezone of approximately 47.41 acres of land located at approximately 5047 N. Droubay Road in Erda, from RR-5 (Rural Residential, Five-Acre Minimum Lot Size) to RR-1 (Rural Residential, One-Acre Minimum Lot Size); and

WHEREAS, public notice of the requested zone change was provided as required by UCA Section 17-27a-205; and

WHEREAS, the Planning Commission conducted a public hearing and discussed the requested zone change; and

WHEREAS, the Planning Commission voted to recommend the requested zone change;

**NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF
TOOELE COUNTY, UTAH AS FOLLOWS:**

SECTION I – AMENDMENT. The official zoning map of Tooele County is hereby amended by changing the zoning designation of approximately 47.41 acres, known as Parcel 05-043-0-0056 in Tooele County, Utah from RR-5 (Rural Residential, Five-Acre Minimum Lot Size) to RR-1 (Rural Residential, One-Acre Minimum Lot Size).


A map showing the area of the rezone is attached hereto and by this reference made a part hereof.
