

**TOOELE COUNTY  
ORDINANCE 2021-30**

**AN ORDINANCE ENACTING CHAPTER 8, URBAN FARMING  
ASSESSMENT, OF TITLE 2, TAXATION, OF THE TOOELE COUNTY  
CODE**

**WHEREAS**, Utah Code Title 59, Chapter 2, Part 17, known as the Urban Farming Assessment Act, authorizes qualifying land to be assessed as agricultural land; and

**WHEREAS**, the Urban Farming Assessment Act requires each county to adopt an urban farming assessment ordinance before land in that county can be assessed as agricultural land under the Urban Farming Assessment Act; and

**WHEREAS**, the Tooele County Council hereby determines that allowing land to qualify for agricultural assessment under the Urban Farming Assessment Act will benefit county residents who participate in urban farming;

**NOW, THEREFORE, BE IT ORDAINED BY THE LEGISLATIVE BODY OF TOOELE COUNTY, UTAH AS FOLLOWS:**

**SECTION I – CHAPTER ENACTED.** Chapter 8, *Urban Farming Assessment*, of Title 2, *Taxation*, of the Tooele County Code is hereby enacted to read as attached hereto, which attachment is, by this reference, made a part hereof.

**SECTION II – REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION III – EFFECTIVE DATE.** This ordinance shall become effective fifteen (15) days after its passage, provided it has been published, or at such publication date if more than fifteen (15) days after passage.

**IN WITNESS WHEREOF** the Tooele County Council, which is the legislative body of Tooele County, passed, approved and enacted this ordinance this 29<sup>th</sup> day of June, 2021.

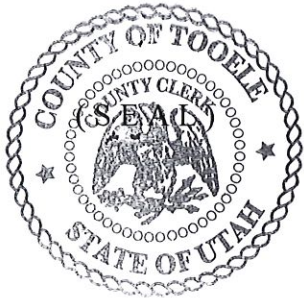

**2-8-1. Authority.**

This chapter is adopted pursuant to Utah Code Title 59, Chapter 2, Part 17, the Urban Farming Assessment Act.

**2-8-2. Adoption of Urban Farming Assessment Act.**

The Urban Farming Assessment Act, as it currently exists or as it may be amended from time to time, is hereby adopted by reference.

**2-8-3. Compliance with Urban Farming Assessment Act.**

(1) Persons who engage in urban farming in Tooele County are hereby authorized to apply for agricultural assessments on land dedicated to urban farming pursuant to the provisions of the Urban Farming Assessment Act.

(2) The assessor is authorized and directed to assess qualifying land under the provisions of the Urban Farming Assessment Act.
