De-obligation amendment to contract

Summary:

This is an amendment to existing contract. It is unspent BLM funds they set aside to pay for our deputies to work BLM area shifts. We have not been able to work sufficient shift to spend all they have obligated to Tooele County due to staffing levels. This amendment de-obligates a portion of the funds so BLM can use them elsewhere.

No money is being requested, and this contract runs from Oct to Sept.
