A RESOLUTION ESTABLISHING THE SALARIES OF THE TOOELE COUNTY OFFICERS FOR THE 2022 FISCAL YEAR

WHEREAS, Utah Code Annotated, Section 17-36-15 requires the Tooele County Council to adopt by resolution its 2022 fiscal year budget, including the salaries of the Tooele County officers, on or before the last day of the fiscal period, which is December 31, 2021; and

WHEREAS, the tentative budget and all supportive schedules and data were available for public inspection, including the salaries of the Tooele County officers, during business hours at the office of the County Auditor for at least ten (10) days prior to the public hearing on the adoption of the final budget as required by Utah Code Annotated, 17-36-11; and

WHEREAS, the Tooele County Assessor has determined not to appoint a chief deputy; and

WHEREAS, Utah Code Annotated, Section 17-16-14, requires the Tooele County Council to fix the salaries of the Tooele County officers for the 2022 fiscal year; and

WHEREAS, pursuant to Utah Code Annotated, Section 17-16-14, a public hearing on the proposed salaries of the county officers for the 2022 fiscal year was regularly noticed up and conducted by the Tooele County Council on December 7, 2021.

NOW, THEREFORE, BE IT RESOLVED BY THE TOOELE COUNTY COUNCIL that the annual salaries for the 2022 fiscal year for Tooele County officers, presented on the attached Exhibit A, and by this reference made a part hereof, are hereby adopted and fixed as so stated.

^{*}Stated salary amounts are annualized, based on the current pay-rate. They are not necessarily equal to the actual annual salaries that officers will receive for the year.

Except for council members, all county officers listed above shall receive, in addition to the above-mentioned salaries, the same retirement and other fringe benefits afforded all other Tooele County employees, including family health/dental coverage.

Council members may enroll themselves and their immediate family members in insurance programs offered to full-time county employees but shall pay the entire premium for such coverage without county contribution.

Tooele County constables shall not receive any compensation, salary, insurance, or other employee fringe benefits afforded other county employees. The constables' reimbursement shall be derived exclusively from statutory fees charged for services provided.
