MEMORANDUM OF UNDERSTANDING

Between the

Department of the Interior, Bureau of Land Management, Wells Field Office and Tooele County, Utah as a Cooperating Agency

This MEMORANDUM OF UNDERSTANDING, (MOU) establishes a cooperating agency relationship between the Department of the Interior, Bureau of Land Management, Wells Field Office (BLM) and Tooele County, Utah (Tooele County) for the purpose of preparing the Environmental Assessment (EA) for the West Wendover Land Conveyance Project (Project). The BLM is the lead federal agency for development of the EA. The BLM acknowledges that Tooele County has special expertise that is applicable to the EA effort, as defined at 40 CFR 1508.1(e) and 1508.1(ee). This MOU describes responsibilities and procedures agreed to by Tooele County as a Cooperating Agency and the BLM.

The purpose of this MOU is to: 1) Establish and maintain coordination between Tooele County and the BLM in recognition of Tooele County's special expertise regarding social and economic values of the areas potentially impacted by the Project and 2) Coordinate and exchange social, economic, and local information relating to the EA that will be prepared for the proposed actions and alternatives.

Tooele County's role as a cooperating agency is limited to technical review of social and economic issues for the EA. This participation does not imply endorsement of the Project or preferred alternative. The point of contact for Tooele County will be Tooele County's designated representative.

- During the development of the proposed action and alternatives for the EA, Tooele
 County will maintain close communication with BLM and provide technical
 guidance for any recommended additions or deletions concerning social and
 economic values issues.
- 2. At the administrative drafting stage of the EA, Tooele County will review any technical documents, including that portion of the administrative draft EA concerning social and economic values and will advise the BLM on the technical adequacy and completeness of these documents. Tooele County will not release or share any administrative draft documents outside of their organization.
- 3. Tooele County may advise changes to the social and economic values sections of the EA as well as interpret these comments to the BLM, as necessary. Additionally, BLM will provide Tooele County an opportunity to review appropriate sections of the administrative Draft EA to determine if data and comments provided by Tooele County have been accurately represented. However, Tooele County will not be responsible for preparation of any portion of the EA or related report and is not responsible for the adequacy of the EA.

- 4. Staff time and budget permitting, Tooele County will participate in major interagency meetings to discuss the Project and the review process (including agency responsibilities and work schedules concerning social and economic values).
- 5. Tooele County's advice on social and economic components is contingent upon adequate review time. Tooele County will have not less than two weeks or more than three weeks, or other period of time as negotiated, for review of the administrative draft EA upon receipt of these documents. For the draft EA and/or final EA, comment/review periods for Tooele County will be the same as that for the general public and other state and federal agencies. Any other pertinent correspondence received by Tooele County from the BLM will be responded to in a timely manner.

The cooperating agency relationship established through this MOU shall be governed by all applicable statutes, regulations, and policies, including the Council on Environmental Quality's National Environmental Policy Act (NEPA) regulations (in particular, 40 CFR 1501.8), the BLM's planning regulations (in particular, 43 CFR 1601.0-5, 1610.3-1, and 1610.4), and the Department of the Interior Manual (516 DM 2.5).

Authority for the BLM and Tooele County to participate in this agreement is provided by the National Environmental Policy Act of 1969 (42 USC 4321 et seq.), the Federal Land Policy and Management Act of 1976 (43 USC 1701 et seq.), Council of Environmental Quality regulations on implementing NEPA (40 CFR Part 1501 et seq.), and BLM planning regulations (43 CFR 1601 et seq.).

This agreement is not intended to limit any Federal or State laws, rules or regulations or any other requirements or duties under such laws, rules or regulations. This agreement is not intended to give any agency additional authority beyond current laws, rules, or regulations.

This MOU shall become effective upon signature by Tooele County and the BLM Wells Field Office Manager and will remain in effect until a decision for the Project EA is completed.

Amendments to this agreement may be proposed any time by any party and shall become effective upon written approval by all parties. Any of the parties, after 60 days written notice to other agencies, may terminate this agreement.

Any information furnished to the BLM under this agreement is subject to the Freedom of Information Act (5 USC 552).
