

**TOOELE COUNTY  
ORDINANCE 2022-16**

**AN ORDINANCE RENAMING AND AMENDING CHAPTER 16,  
OVERNIGHT CAMPING, OF TITLE 6, PUBLIC SAFETY, OF THE  
TOOELE COUNTY CODE**

**WHEREAS**, Tooele County has public campgrounds and other public areas where camping is allowed; and

**WHEREAS**, limiting the number of days that persons can camp in Tooele County's public campgrounds and other public areas will protect natural resources, address sanitation issues, prevent persons from monopolizing popular camping sites, and control squatting; and

**WHEREAS**, the public will benefit from imposing limits on the number of days that persons can camp in Tooele County's public campgrounds and other public areas; and

**WHEREAS**, a renamed and amended Title 6, Chapter 16 is expedient and necessary;

**NOW, THEREFORE, THE COUNTY LEGISLATIVE BODY OF TOOELE COUNTY ORDAINS AS FOLLOWS:**

**SECTION I – CHAPTER RENAMED AND AMENDED.** Chapter 16, *Overnight Camping*, of Title 6, *Public Safety*, of the Tooele County Code is hereby renamed to *Camping* and amended to read as attached hereto, which attachment is, by this reference, made a part hereof.


**SECTION II – REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION III – EFFECTIVE DATE.** This ordinance shall become effective fifteen (15) days after its passage, provided it has been published, or at such publication date if more than fifteen (15) days after passage.



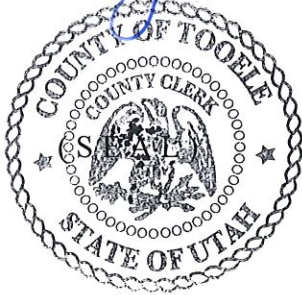
