Locating Company's underground utilities and facilities (upon request by the company), prior to excavation as described in the original contract.

## MODIFICATIONS:

1. **Modification of Contact Pricing.** All previous pricing will be deleted and replaced with the following. However, if ticket volumes drop back down to below 30 per month for three consecutive months, ELM has the right to revert back to a Monthly Minimum model at \$750.00/month.

Description	Price
Locate Regular (0-500'; 500' increments thereafter)	\$19.75
Regular Hourly – Standby & Monitor (2 hour minimum)	\$52.00
Hourly After Hours (2 hour minimum)	\$68.00

- Hourly units will not be charged in conjunction with Locate units. Hourly units
  are for standby & monitor services or other hourly work as requested by Company.
- Hourly After Hours charges will be billed for emergency call outs that occur during non-business hours in lieu of regular locate charges.
- All tickets generated under Company member code & transmitted from the Call Center will be received directly by contractor, with no screening being done by company.
- All tickets received will be counted and/or billed a minimum of 1 Locate Regular.
- 2. **Fuel Adder.** If gasoline prices for regular grade rise for more than thirty (30) days to \$5.50/gallon as published in the AAA Gas Price Index in individual Markets, there will be a .5% surcharge added to all pricing line items in the applicable Market. Additional .5% surcharges will be implemented for every \$.50/gallon thereafter of the published rate in the individual markets. Surcharge amounts for the current quarter will be determined with the published rate on the AAA Gas Price Index for the last day of the previous quarter. If the gas price falls below \$5.50 per gallon, the surcharge will be removed.
- 3. **Terms and Conditions.** All other terms and conditions will remain the same.

The above payment, termination, and/or time adjustments shall constitute the entire and complete adjustment for the above modifications to the herein referenced contract.
