Item Title: Extension of Road Maintenance (Erda City) - Council

Erda has requested that the county provide road maintenance for an additional three months (from July 1, 2022 through September 30, 2022). This extension to the interlocal agreement enables that request.

**EXTENSION OF ROAD MAINTENANCE PROVISIONS OF
INTERLOCAL COOPERATION AGREEMENT DATED MARCH 15, 2022
BETWEEN TOOELE COUNTY AND ERDA CITY**

AGREEMENT dated this 21st day of June, 2022, between Tooele County ("County") and Erda City ("Erda"), political subdivisions of the State of Utah.

WHEREAS, County and Erda entered into an interlocal cooperation agreement ("agreement") dated March 15, 2022; and

WHEREAS, the agreement addressed, among other things, road maintenance; and

WHEREAS, the road maintenance provisions of the agreement are scheduled to expire on June 30, 2022; and

WHEREAS, County and Erda mutually desire to extend the road maintenance provisions of the agreement through September 30, 2022; and


WHEREAS, the agreement requires that modifications to the agreement must be in writing and must be approved by the parties' respective legislative bodies;

NOW THEREFORE, the parties mutually agree as follows:

1. From July 1, 2022, through September 30, 2022, County will perform the same types and levels of road maintenance (including weed spraying and mowing) that it performed prior to Erda's incorporation. Erda will pay \$51,720 to County by paying to County all road funds received by Erda from the State of Utah within 30 days of receipt until the contracted amount has been paid in full. If, after paying all road funds received from the State of Utah for the period from July 1, 2022, through September 30, 2022, the amount of road funds received from the State of Utah is insufficient, Erda will pay the difference no later than 60 days after invoice from County.

2. All other terms and conditions of the agreement shall remain in full force and effect.


