## TOOELE COUNTY ORDINANCE 2022-20

## AN ORDINANCE AMENDING THE DISABLED VETERAN CANYONS PASS PROVISIONS OF THE TOOELE COUNTY FEE SCHEDULE

WHEREAS, the current county fee schedule allows veterans who have a service-related disability of 50% or more to obtain a free season pass to the Middle Canyon and Settlement Canyon recreation areas; and

WHEREAS, the 50% disability requirement was modeled after the Utah State Parks' Veterans with Disabilities Honor Pass; and

WHEREAS, the 2022 Legislature amended the requirements for the Veterans with Disabilities Honor Pass by deleting the 50% disability requirement, thereby making the Honor Pass available to all disabled veterans; and

WHEREAS, Tooele County desires to remain consistent with the state requirements; and WHEREAS, a majority of the County Council has determined that the canyons pass should be a lifetime pass;

NOW, THEREFORE, THE COUNTY LEGISLATIVE BODY OF TOOELE COUNTY ORDAINS AS FOLLOWS:

**SECTION I – FEE SCHEDULE AMENDED.** The Tooele County Fee Schedule is hereby amended as follows:

Disabled Veteran Lifetime Pass (2-Canyon) for Day Use Only (Present proof of County residency, proof of honorable discharge, and proof of service-related disability to County Auditor's office. Pass is good for up to 7 additional people in same vehicle.)

**SECTION II – REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

**SECTION III – EFFECTIVE DATE.** This ordinance shall become effective fifteen (15) days after its passage, provided it has been published, or at such publication date if more than fifteen (15) days after passage.
