The is a section monument rehabilitation contract with Ensign Engineering.

The contract is for rehabilitation, installing, data collection, and filing of corner records for 52 section survey monuments in the Northeast Rush Valley area. Grant funds will cover \$25,866.67 and Tooele County's match will be \$12,933.33.

This contract is to run from the date of approval with deliverables due to Monument Replacement and Restoration Committee (MRRC) by May 15, 2023 and termination on June 30, 2023.

Section monuments are lost, destroyed, or moved for a variety of reasons. They include, chaining projects, wildfires, artifact collectors, construction projects and so on. UCA 17-23-(4) says in part, the county surveyor shall establish all corners of government surveyors, reestablish all corners, and shall keep a record of established and reestablished corners. These corners are vital for establishing property boundaries.
