

**TOOELE COUNTY
RESOLUTION 2022-50**

**A RESOLUTION ESTABLISHING THE SALARIES OF THE TOOELE
COUNTY OFFICERS FOR THE 2023 FISCAL YEAR**

WHEREAS, Utah Code Annotated, Section 17-36-15 requires the Tooele County Council to adopt by resolution its 2023 fiscal year budget, including the salaries of the Tooele County officers, on or before the last day of the fiscal period, which is December 31, 2022; and

WHEREAS, the tentative budget and all supportive schedules and data were available for public inspection, including the salaries of the Tooele County officers, during business hours at the office of the County Auditor for at least ten (10) days prior to the public hearing on the adoption of the final budget as required by Utah Code Annotated, 17-36-11; and

WHEREAS, Utah Code Annotated, Section 17-16-14, requires the Tooele County Council to fix the salaries of the Tooele County officers for the 2023 fiscal year; and

WHEREAS, pursuant to Utah Code Annotated, Section 17-16-14, a public hearing on the proposed salaries of the county officers for the 2023 fiscal year was regularly noticed up and conducted by the Tooele County Council on December 6, 2022.

NOW, THEREFORE, BE IT RESOLVED BY THE TOOELE COUNTY COUNCIL that the annual salaries for the 2023 fiscal year for Tooele County officers, presented on the attached Exhibit A, and by this reference made a part hereof, are hereby adopted and fixed as so stated.

EFFECTIVE DATE: This resolution shall take effect immediately upon passage.

**Stated salary amounts are annualized, based on the current pay-rate. They are not necessarily equal to the actual annual salaries that officers will receive for the year.*

All county officers listed above shall receive, in addition to the above-mentioned salaries, the same retirement and other fringe benefits afforded all other Tooele County employees, including family health/dental coverage.

Tooele County constables shall not receive any compensation, salary, insurance, or other employee fringe benefits afforded other county employees. The constables' reimbursement shall be derived exclusively from statutory fees charged for services provided.
