### TOOELE COUNTY ORDINANCE 2023-01

AN ORDINANCE AMENDING SECTION 4-21-2, MEMBERSHIP, OF CHAPTER 21, COUNTY FAIR BOARD, OF TITLE 4, BOARDS AND COMMITTEES, OF THE TOOELE COUNTY CODE

WHEREAS, it is no longer expedient that a county council member serves on the Tooele County Fair Board; and

WHEREAS, it is expedient that a high-ranking county official serve on the Tooele County Fair Board;

NOW, THEREFORE, THE COUNTY LEGISLATIVE BODY OF TOOELE COUNTY ORDAINS AS FOLLOWS:

**SECTION I – SECTION AMENDED.** Section 4-21-2, *Membership*, of Chapter 22, *County Fair Board*, of Title 4, *Boards and Committees*, of the Tooele County Code is hereby amended to read as attached hereto, which attachment is, by this reference, made a part hereof.

**SECTION II – REPEALER.** Ordinances in conflict herewith are hereby repealed to the extent of such conflict.



## **Chapter 21: County Fair Board**

#### 4-21-2. Membership.

- (1) The board shall consist of no fewer than five and no more than seven members, one of whom shall be a Council member or the County Manager or Assistant County Manager.
  - (2) Board members shall be appointed by the Council.
- (3) The Council shall favor the appointment of County residents but may appoint County nonresidents if the Council determines such appointments to be in the County fair's best interest.
