AN ORDINANCE VACATING A PORTION OF CENTER STREET, SOUTHWEST OF LAKE POINT

WHEREAS, in December of 2018, a Master Development Agreement with Kennecott Utah Copper LLC ("Kennecott") was approved and signed for proposed planned community Adobe Rock Ranch; and

WHEREAS, pursuant to the Master Development Agreement, Kennecott dedicated a road right-of-way to Tooele County for the Center Street and Pole Canyon Realignment Project; and

WHEREAS, the Master Development Agreement states that if the Master Development Agreement is terminated due to referendum or otherwise, the right-of-way reverts to Kennecott; and

WHEREAS, the proposed development was defeated by referendum; and

WHEREAS, the Master Development Agreement was terminated by the County Commission effective November 3, 2020; and

WHEREAS, Tooele County must formally vacate the right-of-way, which consists of a 50-foot wide by 5,084-foot long portion of Center Street South (approximately 5.84 acres); and

WHEREAS, notice of a public hearing to consider the proposed vacation of the right-ofway was mailed and published and posted as required by Utah Code Section 17-27a-208; and

WHEREAS, the Tooele County Council held a public hearing on February 21, 2023 to consider the proposed vacation, and then voted to vacate the right-of-way;

NOW, THEREFORE, THE COUNTY LEGISLATIVE BODY OF TOOELE COUNTY ORDAINS AS FOLLOWS:

SECTION I – ROAD VACATED. Having provided proper notice, having held a public hearing, and finding good cause therefore, Tooele County hereby vacates the public right-of-way interest in a portion of Center Street South in Tooele County, Utah.

A map showing the area and the right-of-way being vacated, and the legal description of the right-of-way being vacated, are attached hereto and by this reference made a part hereof.

The County's interest in the vacated right-of-way hereby reverts to Kennecott Utah Copper LLC.

The Tooele County Clerk is hereby directed to cause this ordinance to be recorded in the office of the County Recorder.

SECTION II – REPEALER. Ordinances and resolutions in conflict herewith are hereby repealed to the extent of such conflict.

SECTION III – EFFECTIVE DATE. This ordinance shall become effective fifteen (15) days after its passage, provided it has been published, or at such publication date if more than fifteen (15) days after passage.




