TOOELE COUNTY ORDINANCE 2023-11

AN ORDINANCE AMENDING SECTION 9-1-11, TERM OF LICENSE – CERTIFICATE FORM – TRANSFER PROHIBITED, OF CHAPTER 1, GENERAL LICENSING, OF TITLE 9, BUSINESS LICENSE AND REGULATION, OF THE TOOELE COUNTY CODE

WHEREAS, pursuant to county ordinance, the County Clerk is responsible to process business license applications and issue business licenses; and

WHEREAS, pursuant to state law, the County Clerk serves as the county election officer; and

WHEREAS, pursuant to Section 9-1-11 of the Tooele County Code, the annual business license cycle currently runs from July 1 through June 30; and

WHEREAS, the current cycle annually conflicts with the County Clerk's duties as county election officer; and

WHEREAS, the County Clerk would prefer that the annual business license cycle run from January 1 through December 31 to avoid most conflicts with the County Clerk's duties as county election officer;

NOW, THEREFORE, THE COUNTY LEGISLATIVE BODY OF TOOELE COUNTY ORDAINS AS FOLLOWS:

SECTION I – SECTION AMENDED. Section 9-1-11, *Term of License – Certificate* form – Transfer prohibited, of Chapter 1, General Licensing, of Title 9, Business License and Regulation, of the Tooele County Code is hereby amended to read as attached hereto, which attachment is, by this reference, made a part hereof.

SECTION II – REPEALER. Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

SECTION III – EFFECTIVE DATE. This ordinance shall become effective fifteen (15) days after its passage, provided it has been published, or at such publication date if more than fifteen (15) days after passage.

TOOELE COUNTY CODE TITLE 9 BUSINESS LICENSE AND REGULATION

Chapter 1: General Licensing

9-1-11. Term of license – Certificate form – Transfer prohibited.

Unless otherwise expressly provided, the following shall apply to all licenses issued pursuant to this title:

- (1) All licenses shall be issued for a period of one year which shall extend from July 1 to June 30 January 1 to December 31.
- (2) Every certificate of license shall specify by name the person to whom it is issued, and shall designate the particular type of business licensed and the location.
- (3) No license shall be in any manner assignable or transferable, neither shall it authorize any licensee to do business at any other place than indicated in such license, or authorize any other business than is therein mentioned, except by permission of the County Council or unless otherwise provided herein.

Chapter 1: General Licensing
