

**TOOELE COUNTY
ORDINANCE 2023-16**

AN ORDINANCE REPEALING CHAPTER 19, ACCIDENT REVIEW BOARD, OF TITLE 4, BOARDS AND COMMITTEES, OF THE TOOELE COUNTY CODE

WHEREAS, conflicting provisions governing the Accident Review Board are currently found in: (1) County Code, Title 4, Chapter 19; and (2) County Personnel Policies and Procedures, Section 14; and

WHEREAS, the Accident Review Board is an internal county committee closely affiliated with the Human Resources Department; and

WHEREAS, the provisions in County Code, Title 4, Chapter 19 are far less specific than the provisions in County Personnel Policies and Procedures, Section 14; and

WHEREAS, it is fitting that County Code, Title 4, Chapter 19 be repealed;

NOW, THEREFORE, THE COUNTY LEGISLATIVE BODY OF TOOELE COUNTY ORDAINS AS FOLLOWS:

SECTION I – CHAPTER REPEALED. Chapter 19, *Accident Review Board*, of Title 4, *Boards and Committees*, of the Tooele County Code is hereby repealed.


SECTION II – REPEALER. Ordinances in conflict herewith are hereby repealed to the extent of such conflict.

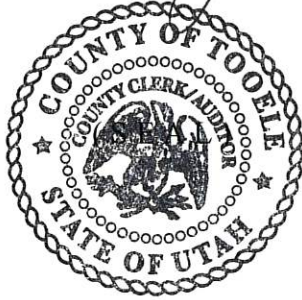
